In accordance with the Ethical Standards in Public Life etc (Scotland) Act 2000, and the Code of Conduct for Members of NHS Ayrshire & Arran (adopted from the Model Code of Conduct for Members of Devolved Public Bodies), Board members of devolved public bodies are required to give notice of their interests.

The Board's Standards Officer (Head of Corporate Governance) will maintain a Register of Members' Interests, which is available for public scrutiny.

It is the duty of each Board Member to declare all interests relevant and material to the Board's business and to ensure that their entry in the register is kept up to date. Any changes to the information first registered, must be given in writing to the standards officer, in the prescribed format, within one month of the change arising.
