1. Purpose

2. Report summary

2.1 Situation

A Corporate Calendar is compiled annually to capture dates for a Board meetings and workshops, the Board annual development session, Governance Committees, Endowment Trustees and Endowment Committee and Integration Joint Board (IJBs) and subcommittees.

This provides assurance to the NHS Board that Board Committees have established dates for meetings through 2020-2021 and provides information on IJB meeting dates. In addition the report provides assurance of the process taken to deliver the 2020-2021 meeting schedules.

2.2 Background

Our local process has been to publish the Corporate Calendar annually as soon as Board Committee and IJB information is available, via the NHS Board.

In addition to this local process, in December 2019, The <u>NHS Boards - Model</u> <u>Standing Orders - DL(2019)24</u> were published. The Model states at section 9.2 that "The Board shall approve a calendar of meeting dates for its committees". The Corporate Calendar will continue to be submitted to the Board annually to provide assurance to the NHS Board of our governance arrangements.

2.3 Assessment

In planning the corporate calendar for 2020-2021, discussions were held with the Risk Management team and Governance Committee Secretaries to enable delivery of a robust corporate meeting schedule that would align as much as is practicable with schedules for risk, financial and performance reporting.

Dates for each Board Committee were agreed by the Committee. Once agreed dates were issued to members.

Board Annual Development session - date will be agreed with the new Board Chair once the person has been appointed and in post.

Board workshops - dates for 2020-2021 have been set in agreement with the interim Board Chair and align with known requirements for topics and operational availability to deliver sessions. The dates are subject to change to meet business need.

Integrated Governance Committee - dates have arranged to align with the strategic governance needs of the Caring for Ayrshire programme.

We work in partnership with the Ayrshire IJBs to include their meeting dates and wherever possible seek to ensure that there are no clashes with Board Committees. The IJBs manage their planning process independently.

2.3.1 Quality/patient care

Ensuring an effective governance process and meeting schedule supports the delivery of patient care and services.

2.3.2 Workforce

There is no impact on workforce from this paper.

2.3.3 Financial

2.3.4 Risk assessment/management
