2.3 Briefing

As the Board continues to work under emergency planning conditions the gathering of Good News from across our services has been paused at this time. However our Allied Health Professional (AHP) colleagues wished to share the good news below.

Occupational Therapist Development Programme for West of Scotland

The Elizabeth Casson Trust is a charity with a purpose to advance the profession of occupational therapy through research, education and the development of occupational therapists.

The Trust has recently approved funding to deliver the following programme across the West of Scotland to Occupational Therapists. Occupational Therapists from across Ayrshire and Arran are taking the opportunity to participate.

The 12 week programme will be delivered virtually between September and Christmas 2020 and involves a mixture of online self-directed learning and a virtual learning set, supported by a Virtual Tools Box. This provides an opportunity for 70 OTs at Band 5/7 or equivalent across the 16 Health and Social Care Partnerships (HSCPs) in the West of Scotland Region and the Forensic Network, with four places allocated for each HSCP (two NHS + two local authority).

Emma Stirling, Associate AHP Director in NHS A&A is supporting the programme by providing facilitation, with senior AHP friends of FMA.

The culmination of the programme will involve each participant creating a square for a virtual quilt that will represent the compass for OTs in the Covid Recovery space. Whilst created virtually in the first instance we hope to pull together a quilt through engagement with a group of local quilters.
