2. Report summary

2.1 Situation

These revised Terms of Reference for Healthcare Governance Committee are presented to the Board for approval following recommendation by internal audit to further refine these to include details of reporting and areas over which the committee will seek assurance.

2.2 Background

NHS Ayrshire & Arran Governance Committees' Terms of Reference are reviewed annually and presented to the NHS Board for approval. In early 2020 the Healthcare Governance Committee (HCGC) Terms of Reference were reviewed to align with the revised NHS Board Standing Orders approved by the NHS Board in March 2020. The Healthcare Governance Committee supported the changes and the changes were subsequently approved at the NHS Board meeting on 17 August when submitted as part of the HCGC Annual Report.

2.3 Assessment

The Healthcare Governance Committee Terms of Reference have been further amended to reflect the Healthcare Governance Committee internal audit carried out in August 2019, specifically in relation to the following recommendation:

"The Committee's Terms of Reference should be enhanced around its subcommittees reporting arrangements, good practice would require that the reporting framework be made transparent (into and out of the Committee). Additionally the Terms of Reference should be more prescriptive over areas that the Committee look to gain assurance over"

This version of the Terms of Reference was presented to the Healthcare Governance Committee at their meeting on Monday 14 September 2020, and the changes were supported for onward submission to the NHS Board for approval.

2.3.1 Quality/patient care

NHS Ayrshire and Arran Governance Committees' Terms of Reference are revised annually or otherwise indicated (i.e. following internal audit recommendations) to ensure these accurately reflect the remit, scope and purpose of the Governance Committee, in keeping with good corporate Governance. The role of the Healthcare Governance Committee is to have scrutiny and gain assurance over a range of areas, including quality and patient care.
