2. Report summary

2.1 Situation

This paper provides an update to NHS Board member nominees for the East Ayrshire Integration Joint Board (EA IJB) and seeks Members' approval.

2.2 Background

The NHS Board Standing Orders advises that membership of Board committees is a reserved matter for Board approval.

The Board Chair reviews representation on Board Committees and IJBs as required and at least annually. This includes engagement with Non-Executives through the appraisal process to consider their views. This ensures good governance practice in the best use of Non-Executive skills and experience across our governance committees.

2.3 Assessment

Vacancy/replacement

Professor Hazel Borland retires from NHS Ayrshire & Arran on 31 March 2022 and steps down from the EA IJB. As advised in the paper to Board on 30 January 2022 the Board Chair has considered the resulting vacancy and has nominated the Board's

new Nurse Director, Jennifer Wilson, as a member of the EA IJB. To take effect from 1 April 2022 for a three year term.

Reappointment

Michael Breen, Non-Executive Member, comes to the end of his first term of appointment on EA IJB on 30 April 2022. Michael has been nominated for a second term on the EA IJB.


