## 2. Report summary

#### 2.1 Situation

The current Ayrshire and Arran NHS Board Chair has agreed a six month period of medical leave with Scottish Government and a second Vice Chair and Interim Board Chair has been appointed from the Non-Executive Member cohort. This required a review and changes to Board Committee and Integration Joint Board members to ensure a continued robust governance committee framework. Proposals for interim arrangements for Board Committees and South Ayrshire Integration Joint Board are presented to Members for approval.

Board members approved this paper by email during early July 2024 and the proposals are now presented for Board for formal approval.

### 2.2 Background

The NHS Board Standing Orders (6.2b) advises that appointment of members to Board committees is a reserved matter for Board approval.

The allocation of responsibilities for Non-Executive Board Members is reviewed as people leave and join the Board and as a minimum the Board Chair, Vice Chair and Head of Corporate Governance review responsibilities annually. This review takes into account discussions with Non-Executives at annual appraisals and the skills and

experience that our Non-Executives bring to the Board to ensure the best use of skills and experience across our Board committees. Any changes will be subject to Board approval.

#### 2.3 Assessment

#### Board Chair

As reported previously to Board Members, our current Chair of Ayrshire and Arran NHS Board, Lesley Bowie, is taking a period of medical leave following advice from a cardiologist, to 30 November 2024. Support was sought from Scottish Government to appoint an Interim Chair. The Cabinet Secretary Health and Social Care has confirmed the appointment of Linda Semple, Non-Executive Member, as a second Vice Chair and to take up the role of Interim Board Chair from 17 June 2024 for a period of six months.

#### Committee changes:

As Interim Board Chair, Linda Semple will step down from: Healthcare Governance Committee (Chair); Performance Governance Committee (Vice Chair) and South Ayrshire Integration Joint Board (Chair) and Integrated Governance Committee.

Linda will continue in her role as Pharmacy Practices Committee Chair and this will be reviewed if required in the six month interim period. Linda will also continue in her role as Chair of the Strategic Climate Emergency and Sustainability group. Her role as Chair of the Medicines Appeal Panel is only required should an Appeal be escalated.

The Interim Board Chair considered the range of skills available to ensure that Committees continue to have as strong a membership as possible. The proposed interim amendments to Committee Membership from 1 July 2024 to 31 December 2024 are outlined below:

- Healthcare Governance Committee
  - Joyce White will join Healthcare Governance Committee and take on the role of Committee Chair.
- Performance Governance Committee
  - Jean Ford will join Performance Governance Committee as a Member.
- Integrated Governance Committee
  - Sheila Cowan, Board Vice Chair, will take on the role of Chair of Integrated Governance Committee.
  - As Chair of Healthcare Governance Committee, Joyce will become a member of Integrated Governance Committee
  - Members are asked to support an interim derogation to the Committee Terms of Reference which state that the Board Chair will chair the Integrated Governance Committee. As an interim measure this is being filled by the Board Vice chair.
- South Ayrshire Integration Joint Board (SA IJB)
  - Jean Ford has agreed to take up the SA IJB Chair role on an interim basis. Jean is already a member of SA IJB.
  - Neil McAleese has been nominated and agreed to join the SA IJB on an interim basis.

 Liam Gallacher will join the SA Strategic Planning Group, a subgroup of SA IJB. Liam will also join South Ayrshire Performance and Audit committee on an interim basis.

In addition, it is noted that:

 North Ayrshire Integration Joint Board (NA IJB). Marc Mazzuco, Non-Executive Member, comes to the end of his first term of appointment on NA IJB on 31 October 2024. Marc has been nominated for a second term on the NA IJB.

In supporting these interim arrangements, the additional time commitment required of Non-Executive members and the support offered to ensure a robust governance committee framework is acknowledged by all Members. The Chief Executive and Interim Board Chair note thanks to all Members for their continued support.

We are continuing to engage with the national Public Bodies Appointment Team to progress the ministerial appointment process for a new Non-Executive to fill the existing Non-Executive vacancy.

Appendices 1 and 2 show the updated matrix for Non-Executive Committee responsibilities and Integration Joint Board membership.

## 2.3.1 Quality/patient care

Ensuring that members of Board Committees have the right skills and experience to scrutinise and challenge will ensure that decisions which may impact on quality of patient care are made in line with good governance practice.

#### 2.3.2 Workforce

There are no workforce implications from the position presented.

#### 2.3.3 Financial

Where Non-Executive board members meet the criteria set out and agreed by Remuneration Committee in 2016, additional payments will be made of one day per month. This is in accordance with Scottish Government direction and does not apply to Stakeholder members. The financial impact of the Board Chair interim arrangements and Non-Executive remuneration has been reviewed and this will be monitored closely to minimise any overspend incurred in ensuring that the Board delivers on required corporate governance. The current Non-Executive vacancy budget will minimise the cost pressures.

## 2.3.4 Risk assessment/management

Risks in relation to time commitments for Non-Executives are considered during the annual review process and discussed at individual appraisals. The additional time commitment for Non-Executives has been recognised and as noted above, additional payments will be made as appropriate.

#### 2.3.5 Equality and diversity, including health inequalities

An impact assessment has not been completed as there is no impact in relation to inequalities or protected characteristics.

#### 2.3.6 Other impacts

 Best value - ensures good governance practice in the best use of Non-Executive skills and experience across our governance committees and

- enables Non-Executive members to make an active contribution to effective governance.
- Appropriate representation on the Ayrshire Integration Joint Boards enables
  effective partnership working with health and social care to deliver
  governance and accountability, effective use of resources and performance
  management through IJB Performance and Audit governance committees.
- Compliance with Corporate Objectives Effective committees support delivery of Corporate objectives

## 2.3.7 Communication, involvement, engagement and consultation

The Board Chair engages with Non-Executives, Committee Chairs and executive officers as appropriate in proposing committee members.

## 2.3.8 Route to the meeting

This has not previously been considered by other groups.

- o Approve the interim changes to committee and IJB membership.
