the financial year 2024-25 and the current overall projected year end overspend of £6.555m, reduced to £3.143m through already identified financial recovery actions (ii) the progress with delivery of agreed savings, (iii) the actions being taken to progress financial recovery and a further recovery plan to be presented to IJB in September, (iv) the remaining financial risks for 2024-25; (b) approve the budget reductions set out at section 2.10 of the report; and (c) the Terms of Reference for the Finance Working Group set out at Appendix F to the report.

## 7. Accounts Commission: Integration Joint Board Finance and Performance

Submitted report by Paul Doak, Head of Service (HSCP Finance and Transformation) on the recently published Accounts Commission report and the findings from their national analysis of IJBs, set out at Appendix 1 to the report.
