	P White explained that there has been interest from other areas of Scotland about the ageing well work in South Ayrshire including Perth and Kinross, Borders and Dumfries and Galloway.	
	P White continued to inform that there was a successful inter- generational event, Age Without Limits, on 20 <sup>th</sup> March (Ageism Action Day) at Belmont Academy led by VASA. This was a wonderful sharing of insights from one generation to another.

6.	Microenterprise	
	P White advised that the purpose of this report is to update IJB members on Micro-enterprise work and to set out a proposed way forward for the work over the next 2 years and to agree the financial contribution for the health and care component of the work.	
	P White informed that an update was presented to IJB in June 2023 on the Microenterprise work initiated in South Ayrshire in late 2022 under CAyr.	
	P White explained that they have continued with the same areas and at that point it was about link to economic development landscape. P White advised that they have had a number of negotiations with wider economic development mechanisms at an Ayrshire level.	
	P White informed that Ayrshire Beats have signalled that they have completed the development work that they agreed to lead on and are keen to now step down.	
	P White explained that they have also received input from officers with relevant expertise in Social Work Scotland and Somerset Council (where there are over a thousand Microenterprises, advising that they have 1400 micros they have grown, and which now constitute the majority of their care.	
	P White advised that there is significant interest from a Scottish-wide perspective on the HSCPs local Micro-enterprise work. It has also been informed by inputs from work across the UK (including within Somerset), rural Perthshire and Social Work Scotland. It is also the focus of some wider work on Ethical Commissioning led by the i Hub in Healthcare Improvement Scotland and also links to broader work within Social Work Scotland. There has also been links to In Control Scotland. The South Ayrshire ME will feature in a case study in a forthcoming Ethical Commissioning report for the iHub.	
	P White informed that mircos are relationship based and provide a	





	different level of support to care providers or home care.	
	S McLeod explained that they will offer personal care support, social support and also basic weekly support.	
	P White advised that the proposal for the future is that funding for micros comes from economic development and the IJB would fund the rest through the Improvement and Innovation Fund.	
	G Hoey informed that although he can understand and appreciate the benefits of this service, he does have some concerns around the fact they are not a registered service under the Care Inspectorate.	
	S McLeod explained that as micros are self-employed, they are not entitled to registration with Care Inspectorate or SSSC.	
	S McLeod noted that not all work is regulated as such, therefore a PVG would not always be required. If there were any concerns that a micro's conduct was not satisfactory, they would be removed from the directory.	
	S McLeod assured that anyone who comes on to the directory they hold, must have an up-to-date PVG and anyone who receives support from a micro can request for them to update their PVG at any time.	
	L Semple informed that the governance of micros would not be the responsibility of the IJB, however as they would be partially funding this, she would expect to know the detail to ensure they are happy with the framework. In terms of evaluation, when this happens, it would come to IJB to ensure it is appropriate in terms of safeguarding.

	V Campbell informed that Ayrshire and Arran bid on behalf of the three HSCPs to continue with a pan Ayrshire approach locally and were successful in their bid for an additional £3.5 m (approx. 60wte additional) to further implement the contractual elements of the GMS contract.	
	V Campbell explained that the 2018 GMS contract was introduced to facilitate a refocusing of the GP role as Expert Medical Generalist (EMG). The contract is a joint agreement between the Scottish Government and the British Medical Association (BMA).

	H Brown advised that South Lodge residential unit had been deemed as "not fit for purpose" and had previously reduced its occupied beds leaving the top floor of the unit empty. H Brown explained that this provided an opportunity to utilise the space in South Lodge for the introduction of "Intermediate Care".	
	H Brown highlighted some key data within section 4.1 of the circulated report, from the initial evaluation carried out in August 2023. Overall, with the implementation of the unit, there was a saving of 117 hours per day for care at home.	
	H Brown informed that the initial evaluation highlighted learning and noted some of the conclusions from this (fully detailed within the circulated report).
