2. Report summary

2.1 Situation

The NHS Ayrshire & Arran (NHSAA) Corporate Calendar provides dates for the Board and Board Standing Committee meetings and includes Integration Joint Board (IJB) and IJB subcommittee dates; Corporate Management Team meetings are included for reference. The Board are asked to endorse the Corporate Calendar, noting that meeting dates are approved by individual committees.

2.2 Background

The Corporate Calendar is submitted to the NHS Board annually to provide assurance of our governance arrangements in accordance with the NHS Board Standing Orders which requires that "The Board shall approve a calendar of meeting dates for its committees".

2.3 Assessment

In planning the corporate calendar for 2025-2026, discussions were held with colleagues to deliver a robust corporate meeting schedule that aligns as much as is practicable with schedules for risk, financial and performance reporting. Two Board Committees have to agree their dates formally and these are noted. Each committee will also plan an in-person meeting during the year and dates will be agreed with the Committee Chairs and advised to members.

For 2025/26 there was a change to the schedule of meetings for Performance Governance Committee to ensure that there was a governance flow of performance and financial reporting to the NHS Board with appropriate scrutiny.

The Board workshop schedule for 2025 is in progress and will be developed in discussion with the Board Chair and Chief Executive.

We work in partnership with the Ayrshire IJBs to include their meeting dates and where possible seek to ensure that there are no clashes with Board Committees. The IJBs manage their planning process independently.

2.3.1 Quality/patient care

Ensuring an effective governance process and meeting schedule supports the delivery of patient care and services.

2.3.2 Workforce

2.3.3 Financial

2.3.4 Risk assessment/management
